#### COMMENTS REGARDING THE TABLE

(1) The amounts in the table concern only duly registered students (the amounts for auditing students and students on single module courses are not included here: for single module courses, it is the institutions that determine the amount of tuition fees due).

Moreover, the amounts shown do not include any increased fees that may be collected for certain categories of non-subsidised students.

(2) When a student is registered on several courses during the same academic year, one of the registrations is considered as primary, while the others are considered as secondary (registrations referred to as being "additional tests" in Article 39 of the law of 27/7/1971). The tuition fees for these so-called "additional" registrations are added to those for the primary registration.

(3) These amounts are fixed by law.

(4) The provisions of Article 39 paragraph 2 of the law of 27/7/1971, fixing the fees for the AESS and CAPAES, were extended (by article 26 of the decree voted on 16/12/2009 in the Parliament of the French Community) for students who register for "another focus of the same Master's". This new provision aims to respond to the difficulties encountered because of the difference in the price of the AESS and a teaching-focused Master's for graduates of a 120-credit Master's degree of another focus of the same curriculum.

(5) Under the joint decision adopted by the rectors at the meetings of CRef on 7<sup>th</sup> February and 5<sup>th</sup> May 2006.

(6) Annual limit. This amount cannot be claimed from grant holders, scholarship students or from those with a low income.

(7) This applies to any grant holder or scholarship student (SAE and DGCD) who is eligible under this or any other registration.

## B. Increased Fees

### Amount of increased tuition fees for unassimilated non-EU students<sup>1</sup>

These amounts apply to students:

- who register for the first time at a University in the French Community of Belgium for the 2021-2022 academic year
- who were registered for the first time at a University in the French Community of Belgium from the 2016-2017 academic year onwards
- who register after an interruption of their studies
- who register, on the same study cycle, on a study programme with the aim of achieving a different degree than that which would have been achieved at the end of the study programme they were previously registered on;
- or who re-register for the same study cycle not having acquired a minimum of 75% of the credits from their PAE the previous academic year.

Non-EU students who, for the registration deadline, set in accordance with article 101, paragraph 1, of the Decree of 7<sup>th</sup> November 2013 cited above, satisfy at least one of the following conditions, are exempt from paying increased tuition fees. Students are exempt if they:

- have a school leaving certificate (CESS or equivalent) awarded by a secondary school or a continuing education institution of the French Community after at least two years of study in an institution of the Wallonia-Brussels Federation
- receive a grant from *Wallonie-Bruxelles International*.

<sup>2</sup> 48 countries are currently designated by the United Nations as "Least Developed Countries (LDCs)". Their list is reviewed every 3 years by the United Nations Economic and Social Council. Students who obtain 75% of the credits of their PAE at the end of the previous academic year will receive an exemption for the following years.

Students registered at the University in 2015-2016 and before, and who re-register, are subject to the amounts applicable in 2015-2016.
