COMMENTS REGARDING THE TABLE FROM POINT A

(1) The amounts in the table concern only duly registered students (the amounts for auditing students and students on single module courses are not included here: for single module courses, it is the institutions that determine the amount of tuition fees due).

Moreover, the amounts shown do not include any increased fees that may be collected for certain categories of non-subsidised students except for the reductions listed in point 1.

(2) When a student is registered on several courses during the same academic year, one of the registrations is considered as primary, while the others are considered as secondary (registrations referred to as being "additional tests" in Article 39 of the law of 27/7/1971). The tuition fees for these so-called "additional" registrations are <u>added to those for the primary registration</u>.

This circular applies to students already registered on a study programme between 2014 and 2022 <u>included</u>, provided they are on the corresponding cycle and meet the conditions set out in the circular concerned.

However, in the case of an interruption of at least one academic year, circular 2022-002 is to be applied.

Non-EU students who, for the registration deadline, set in accordance with article 101, paragraph 1, of the Decree of 7th November 2013 cited above, satisfy at least one of the following conditions, are exempt from paying increased tuition fees. Students are exempt if they:

- have a school leaving certificate (CESS or equivalent) awarded by a secondary school or a continuing education institution of the French Community after at least two years of study in an institution of the Wallonia-Brussels Federation
- receive a grant from *Wallonie-Bruxelles International*.

Students who obtain 75% of the credits of their PAE at the end of the previous academic year will receive an exemption for the following years.

Students whose country is listed below are exempt from the higher fees but must pay the standard registration fees specified in point A.

2. ARES Circular 2022-002 of 20th December 2022

This circular applies to students who register for the first time from 2023-2024 at a CfWB institution on a first or second cycle study programme, and for each registration on this programme, as well as to students who re-register when they change study cycle or who re-register at an FWB institution, from the 2023-2024 academic year, after having taken a break of at least one academic year.

The increased fees are due from all students who are nationals of a country that is not listed among the 46 "LDC" countries or among the 20 countries ranked at the bottom of the Human Development Index that are also not listed among the 46 "LDC" countries, and who are registered on a first or second cycle study programme.
