

Admission requirements for 2026-2027

Faculty of Engineering (Polytech Mons)

For reasons of reading ergonomics, this document is not written in inclusive language. It is nonetheless addressed to both men and women, as well as non-binary individuals.

In the event of a divergence between the different linguistic versions of these regulations, the French version shall prevail.

Admission for applicants outside the European Union

Before submitting the application, the applicant must carefully read the 2026-2027 admissions regulations and the admission guide available on the page [Register - Student from outside the European Union - University of Mons \(umons.ac.be\)](http://Register - Student from outside the European Union - University of Mons (umons.ac.be))

By submitting the application, the applicant/student **has read the admission guide and undertake to follow the 2026-2027 Admissions Regulations.**

The applicant whose application has been accepted can only be registered if they are present on Belgian territory no later than 30 September. No extension of the validity date of the form will be granted. The "standard form" is valid **until 30 September inclusive** (Art. 9 of the admissions regulations). Any late registration request will be deemed inadmissible.

General Academic requirements for Admission 2026-2027

For all applicants

- No action will be taken on incomplete applications, and late submissions will be rejected.
- The application fee must be paid according to the instructions on the website.
- The authenticity of the documents provided will be verified. Any falsification of the document will result in the cancellation of admission and a procedure for fraud.
- The personalised cover letter required in the application must preferably be typed and written in French (or possibly in English, if the course in question is taught in English).
- The jury also considers the content of the personalised cover letter attached to the admission file. The jury assesses, through the interest expressed by the candidate in the field of study, the chosen pathway or targeted profession, whether the requested training aligns with their professional and personal project, and if it is in harmony with their profile and any previous education.

Admission requirements for 2026-2027

Master's degree (2nd cycle)

An average of 12/20, or in the absence of a numerical grade, a mention "fairly good" (without prejudice to a more in-depth evaluation of the academic background by the faculty jury), is required for the last year(s) of study taken into account in the evaluation of the application for admission. In the absence of a numerical grade or mention, the file will be sent to the faculty.

Specific academic requirements for admission to the Polytech Mons

Admission to Masters in Polytech Mons (FPMs)

These requirements are in addition to the general academic requirements for admissions to the Master's degree.

The application cannot be accepted pending the successful completion of the current academic year.

- An average of 13/20 in secondary school is required (in the absence of a numerical grade, a "fairly good" grade is required at least. In the absence of a mention and/or grade, the file will be sent to the Faculty). In addition, only grades A, B and C are considered sufficient to meet the 13/20 in the subjects included in the "Advanced Level – General Certificate of Education" (title issued at the end of upper secondary education in the British education system, in some Commonwealth countries and other countries).
- The student must prove sufficient knowledge of the English and/or French language for any application for admission to Master's degree in Civil Engineering.
- In addition to the general requirements for admission to the Master's degree, an average of 12/20 excluding end-of-studies work, internships or other professional integration activities is required, as well as a mark greater than or equal to 12/20 for personal work (end-of-studies work, internships or other professional integration activities).

For admissions to the Master's Degree in Electrical Engineering or Master's Degree in Civil Engineering in Energy Engineering or Master's Degree: Civil Engineering in Computer Science and Management, with a specialization in Artificial Intelligence and Decision Aid:

Knowledge of the English language will be proven by attaching to the admission file either:

An English language certificate, 1 of the 5 following certificates must be submitted

- CAMBRIDGE (minimum score: 160/230);
- IELTS (minimum level: 6);
- TOEIC (minimum level of passive skills 750/990);
- TOEFL ITP (minimum score: 543);

Non-EU applicants – Admission to Master's degree

Admission requirements for 2026-2027

- TOEFL iBT (minimum score: 72/120)

certifying a minimum knowledge of a B2 level (CEFR – European Framework of Reference for Languages) in English will be attached to the application for admission.

Proof that the applicant is registered for one of these tests. The test must then be presented before 15/06 (of the current year). In the event of registration for a test organised after the submission of the application, the application will be processed but no certificate necessary for the issuance of the visa will be sent until the certificate of success is received by UMONS. The student must send a certified copy of his or her results upon receipt of them.

Applicants who have graduated from one of the following English-speaking countries: Australia, the United Kingdom, the United States, New Zealand, South Africa or Canada, automatically meet the English language requirements.

For this master's degree, an A2 level in French is also advisable.

Although the program is mainly taught in English, proficiency in French (minimum level B2) may be required in certain specific situations, particularly for any additional credits that are mainly taught in French. The admissions committee therefore reserves the right to refuse any candidate for whom additional credits are awarded if they cannot demonstrate this language proficiency.

For admissions to other Master's degrees in Civil Engineering:

Knowledge of the English language will be proven by attaching to the admission file either:

An English language certificate, 1 of the 5 following certificates must be submitted

- CAMBRIDGE (minimum score: 160/230);
- IELTS (minimum level: 6);
- TOEIC (minimum level of passive skills 750/990);
- TOEFL ITP (minimum score: 543);
- TOEFL iBT (minimum score: 72/120)

certifying a minimum knowledge of a B2 level in English (CEFR – European Framework of Reference for Languages) will be attached to the application for admission;

Proof that the applicant is registered for one of these tests. The test must then be presented before 15/06 (of the current year). In the event of registration for a test organised after the submission of the application, the application will be processed but no certificate necessary for the issuance of the visa will be sent until the certificate of success is received by UMONS. The student must send a certified copy of his or her results upon receipt of them.

Applicants who have graduated from one of the following English-speaking countries: Australia, the United Kingdom, the United States, New Zealand, South Africa or Canada, automatically meet the English language requirements.

Knowledge of the French language will be proven by attaching to the admission file either:

A French language certificate, 1 of the 3 following certificates must be submitted

- TCF
- TEF

certifying a minimum knowledge of a B2 level (European Framework of Reference for Languages) in French (or, for students graduating from a French-speaking country;

Proof that the applicant is registered for one of these tests. The test must then be presented before 15/06 (of the current year). In the event of registration for a test organised after the submission of the application, the application will be processed but no certificate necessary for the issuance of the visa will be sent until the certificate of success is received by UMONS. The student must send a certified copy of his or her results upon receipt of them.

Applicants who have obtained their diploma with French as the language of instruction can prove their knowledge of the French language with an official certificate from the institution that issued the most recent diploma certifying that the teaching and evaluations were mainly held in French;
